# ASSEMBLING AND PREPARING

## CAUTION

- Always use genuine LG components to ensure safety and product performance.
- The product warranty will not cover damage or injury caused by the use of unauthorized components.
- It is recommended to use the supplied components.
- The product figures and screen displays used in this manual are examples to help consumers use the product and may differ from the actual product.
- Do not apply foreign substances (oils, lubricants, etc.) to the screw parts when assembling the product. (Doing so may damage the product.)
- Applying excessive force when tightening screws may cause damage to the monitor. Damage caused in this way will not be covered by the product warranty.
- Do not carry the monitor upside down by just holding the base. This may cause the monitor to fall off the stand and could result in personal injury.
- When lifting or moving the monitor, do not touch the monitor screen. The force applied to the monitor screen may cause damage to it.
- For wave pattern on appearance; unlike the general method of coating, it's applied to add glittering material in raw material. With no peeled-off appearance, it has good durability. Please use it with confidence because there is no problem in using the product at all.

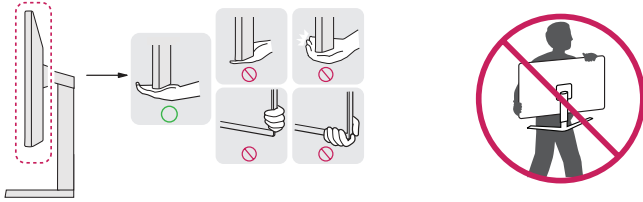

# Installing

## Moving and Lifting the Monitor

When moving or lifting the monitor, follow these instructions to prevent the monitor from being scratched or damaged and to ensure safe transportation, regardless of its shape or size.

- Before moving or lifting the monitor, disconnect the power cord and all other cables.
- Place the monitor in the original box or packing material before attempting to move it.
- Hold the bottom and side of the monitor frame firmly. Do not hold the panel itself.
- When holding the monitor, the screen should face away from you to prevent it from being scratched.
- When transporting the monitor, do not expose the monitor to shock or excessive vibration.
- When moving the monitor, keep it upright and never turn the monitor on its side or tilt it sideways.

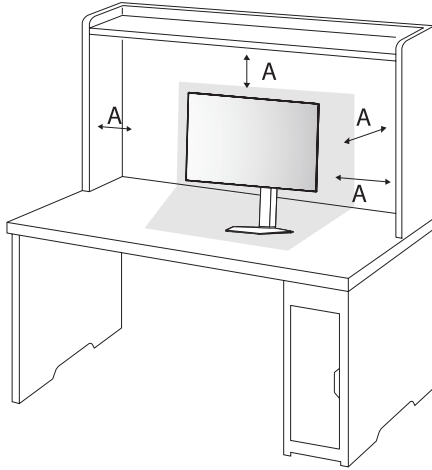


### CAUTION

- Avoid touching the monitor screen as much as possible.
  - This may result in damage to the screen or some of the pixels used to create images.
- If you use the monitor panel without the stand base, its button may cause the monitor to become unstable and fall, resulting in damage to the monitor or human injury. In addition, this may cause the button to malfunction.

## Installing on a Table

- Lift the monitor and place it on the table in an upright position. Place the monitor at least 100 mm (3.9 inches) away from the wall to ensure sufficient ventilation.



A: 100 mm (3.9 inches)

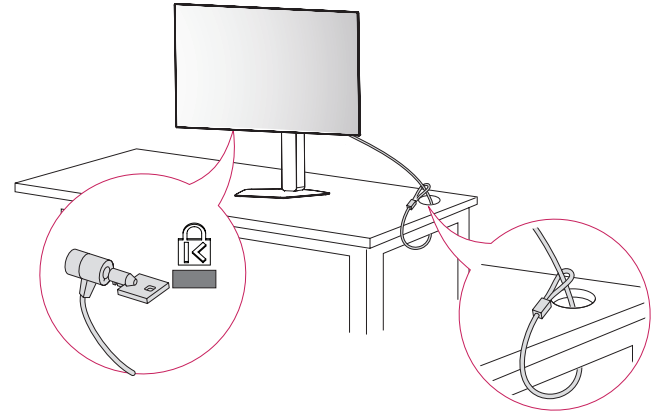
### CAUTION

- Unplug the power cord before moving or installing the monitor. There is risk of electric shock.
- Make sure to use the power cord that is provided in the product package and connect it to a grounded power outlet. (Depending on country)

Connect the monitor to a table using the Kensington security system cable.

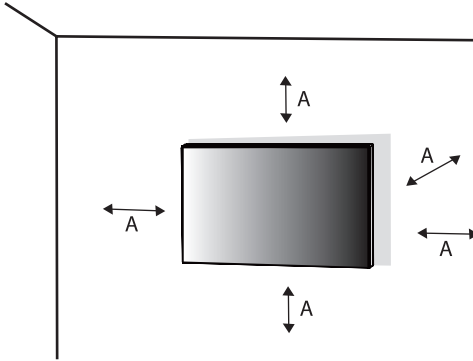

## Installing on the Wall


This monitor meets the specifications for the wall mount plate or other compatible devices. Install the monitor at least 100 mm (3.9 inches) away from the wall and leave about 100 mm (3.9 inches) of space at each side of the monitor to ensure sufficient ventilation. Detailed installation instructions can be obtained from your local retail store. Alternatively, please refer to the manual for how to install and set up a tilting wall mounting bracket.

## Installing the Wall Mount Plate

To install the monitor to a wall, attach a wall mounting bracket (optional) to the back of the monitor. Make sure that the wall mounting bracket is securely fixed to the monitor and to the wall.

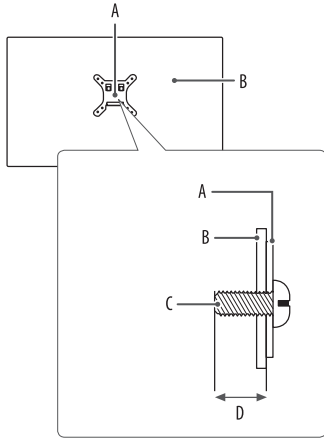
**NOTE**

- Use the screws specified by VESA standards.
- The wall mount kit includes the installation guide and all necessary parts.
- The wall mounting bracket is optional. You can obtain optional accessories from your local dealer.
- The length of the screw may differ for each wall mounting bracket. If you use screws longer than the standard length, it may damage the inside of the product.
- For more information, please refer to the user manual for the wall mounting bracket.
- Be careful not to apply too much force while mounting the wall mount plate as it may cause damage to the screen.
- Remove the stand before installing the monitor on a wall mount by performing the stand attachment in reverse.

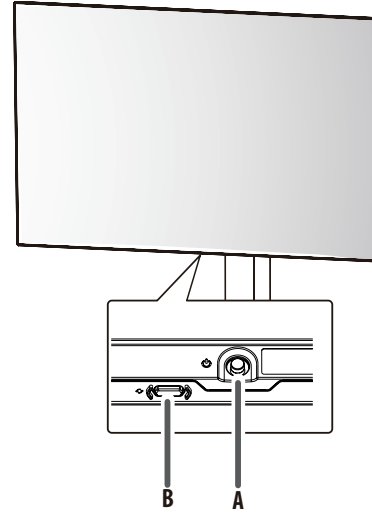
 **CAUTION**

- Unplug the power cord before moving or installing the monitor to avoid electric shock.
- Installing the monitor on the ceiling or on a slanted wall may result in the monitor falling off, which could lead to injury. Use an authorized LG wall mount and contact the local dealer or qualified personnel.
- To prevent injury, this apparatus must be securely attached to the wall in accordance with the installation instructions.
- Applying excessive force when tightening screws may cause damage to the monitor. Damage caused in this way will not be covered by the product warranty.
- Use the wall mounting bracket and screws that conform to VESA standards. Damage caused by the use or misuse of inappropriate components will not be covered by the product warranty.
- When measured from the back of the monitor, the length of each installed screw must be 8 mm (0.3 inches) or less.

- D: Max. 8 mm (0.3 inches)







- A: Joystick Button

## How to Use the Joystick Button

You can easily control the functions of the monitor by pressing the joystick button or moving it left/right/up/down with your finger.

### Basic Functions

**A (Power on):** Press the joystick button once with your finger to turn on the monitor.

**B (Power off):** Press and hold the joystick button once more than 5 seconds with your finger to turn off the monitor.

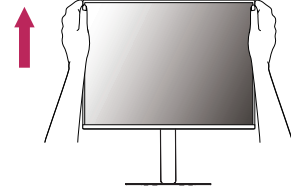
**C (Volume control):** You can control the volume by moving the joystick button left/right.

**D** Enters the [Accessibility] menu.

## Adjusting the Stand Height

- 1 Place the monitor mounted on the stand base in an upright position.
- 2 Handle the monitor with both hands for safety.

### ⚠ WARNING

- When adjusting the screen height, do not place your hand on the stand body to avoid injury to your fingers.

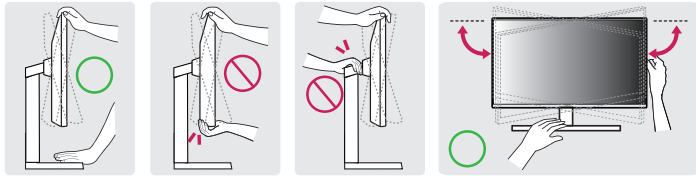
## Adjusting the Angle

- 1 Place the monitor mounted on the stand base in an upright position.
- 2 Adjust the angle of the screen.

The angle of the screen can be adjusted forward or backward from  $-5^{\circ}$  to  $21^{\circ}$  for a comfortable viewing experience. And you can also adjust the angle of the screen by 30 degrees to the left or to the right.

### **!** WARNING

- To avoid injury to the fingers when adjusting the screen, do not hold the lower part of the monitor's frame as illustrated below.
- Be careful not to touch or press the screen area when adjusting the angle of the monitor.

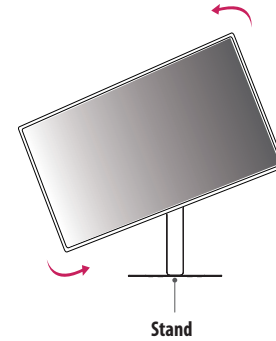


## Pivot Feature

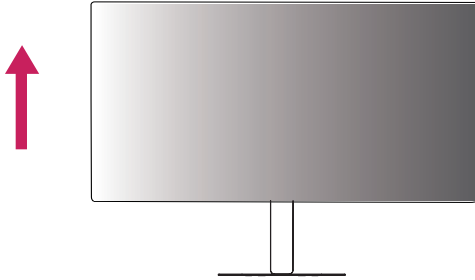
The pivot feature allows the monitor to rotate  $90^{\circ}$  counter-clockwise.

### **!** WARNING

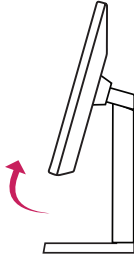
- When using the Pivot function, do not rotate the monitor too fast or with excessive force. The table may be scratched by contact with the monitor's head.
  - The head may come in contact with the stand and scratch the base.
  - Be careful as you may injure your finger by jamming it between the head and the stand.



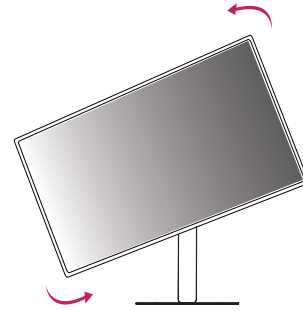
- 1 Raise the monitor up to the maximum height.



- 2 Adjust the angle of the monitor in the direction of the arrow as shown in the figure.



- 3 Rotate the monitor counter-clockwise as shown in the figure.



- 4 Complete the installation by rotating the monitor 90° as shown in the figure.



**NOTE**

- Auto Pivot feature of the display is not supported.
- The screen can be rotated easily using the screen pivot shortcut key provided with your Windows operating system. Note that some Windows versions and some graphics card drivers may use different settings for the screen pivot key or may not support the pivot key at all.

## USING THE MONITOR

- Illustrations in this manual may differ from the actual product.
- Press the joystick button, go to [Settings] > [Input], and then select the input option.

### CAUTION

- If you use generic cables not certified by LG, the screen may not display or there may be image noises.
- Do not press the screen for a prolonged time. This may cause image distortion.
- Do not display a still image on the screen for a prolonged time. This may cause image retention. Use a PC screensaver if possible.
- When connecting the power cord to the outlet, use a grounded (3-hole) power strip or a grounded power outlet. (Depending on country)
- The monitor may flicker when turned on in an area where the temperature is low. This is normal.
- Sometimes red, green, or blue spots may appear on the screen. This is normal.
- Make sure to use the supplied cable of the product. Otherwise, this may cause the device to malfunction.
- If the monitor is reflecting environmental light, move the monitor or light or adjust the strength of the environmental light.

## Connecting to a PC

- This monitor supports the Plug and Play\* feature.
- \* Plug and Play: A feature that allows you to add a device to your computer without having to reconfigure anything or install any manual drivers.

### HDMI Connection

Transmits digital video and audio signals from your PC to the monitor.

### NOTE

- Using a DVI to HDMI / DP (DisplayPort) to HDMI cable may cause compatibility issues.
- Use a certified cable with the HDMI logo attached. If you do not use a certified HDMI cable, the screen may not display or a connection error may occur.
- Recommended HDMI cable types
  - Ultra High Speed HDMI®/™ cable
  - Ultra High Speed HDMI®/™ cable with Ethernet

## DisplayPort Connection

Transmits digital video and audio signals from your PC to the monitor.

### ! NOTE

- There may be no video or audio output depending on the DP (DisplayPort) version of the PC.
- If you are using a Mini DisplayPort output graphics card, use a Mini DP to DP (Mini DisplayPort to DisplayPort) cable or gender that supports DisplayPort2.1 or DisplayPort1.4. (Sold separately)

## USB-C connection

Transmits digital video and audio signals from your PC to the monitor.

### ! NOTE

- PD (Power Delivery) and DP Alternate Mode (DP over USB-C) are supported via USB-C Port.
- Features may not work properly depending on the connected device's specifications and the environment.
- USB-C port is not for the monitor power source but for a PC power source. Connect adaptor to supply power to the monitor.

## Connecting AV Devices

### HDMI Connection

HDMI transmits digital video and audio signals from your AV device to the monitor.

### ! NOTE

- Using a DVI to HDMI / DP (DisplayPort) to HDMI cable may cause compatibility issues.
- Use a certified cable with the HDMI logo attached. If you do not use a certified HDMI cable, the screen may not display or a connection error may occur.
- Recommended HDMI cable types
  - Ultra High Speed HDMI®/™ cable
  - Ultra High Speed HDMI®/™ cable with Ethernet

## Connecting Peripherals

### USB Device connection

The USB port on the product functions as a USB hub.

Peripheral devices connected to the USB IN port can be controlled from the PC.

#### ! NOTE

- It is recommended you install all Windows Updates to keep your Windows up-to-date before connecting to the product for use.
- Peripheral devices are sold separately.
- A keyboard, mouse, or USB device can be connected to the USB port.
- The charging speed may vary depending on the device.
- To use USB Downstream port of monitor, user must connect Upstream port of monitor to Host PC using USB C-C or USB C-A cable.
- When the USB C-C cable is connected between Upstream port of monitor and Host PC, the Downstream port of monitor support USB 2.0 device.
- When the USB C-A cable is connected between Upstream port of monitor and Host PC, the Downstream port of monitor support USB 3.0 device. However, Host PC must support USB 3.0 function.

#### ⚠ CAUTION

- Cautions when using a USB device.
  - A USB device with an automatic recognition program installed, or that uses its own driver, may not be recognized.
  - Some USB devices may not be supported or may not work properly.
  - It is recommended to use a USB hub or hard disk drive with power supplied. (If the power supply is not adequate, the USB device may not be recognized properly.)

### Headset Connection

Connect peripherals to the monitor via the headset port.

#### ! NOTE

- Peripheral devices are sold separately.
- Depending on the audio settings of the PC and external device, headset and speaker functions may be limited.
- The microphone works only when the USB port on the monitor is connected to the USB port on the PC.



Please connect the USB C-C or USB C-A cable to use a microphone function with headphones equipped with a microphone.

## NOTE

- Your monitor's OSD (On Screen Display) may differ slightly from that shown in this manual.
- When [Beep Guide] is activated, pressing the joystick button will take you to [Settings] right away.

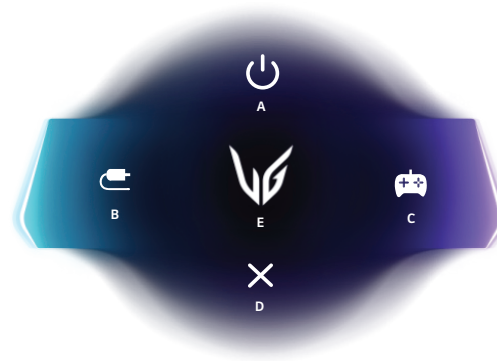
## Activating the Main Menu



Joystick Button

- 1 Press the joystick button on the back of the monitor.
- 2 Move the joystick up/down and left/right to set the options.

## Menu Settings

- 1 To view the OSD menu, press the joystick button at the back of the monitor and then enter the [Settings].
- 2 Move the joystick up/down and left/right to set the options.
- 3 To return to the upper menu or set other menu items, move the joystick to ◀ or press (⏪).
- 4 If you want to exit the OSD menu, move the joystick to ◀ until you exit.

## [AI Boost]

### [Settings] > [AI Boost]

- [AI Upscaling]: AI enhances the resolution and sharpness.
  - [High]: Enhances the resolution and sharpness highly.
  - [Low]: Enhances the resolution and sharpness slightly.
  - [Off]: Doesn't enhance the resolution and sharpness.
- [AI Scene Optimization]: AI analyzes the video and optimizes the picture settings. Available in limited [Game Mode]. ([Personalized Picture]/[Gamer 1]/[Gamer 2]/[FPS]/[RTS]/[Vivid]/[Max Brightness])
- [AI Sound]: AI enhances sound of both internal speakers and connected headphones for an immersive experience.

## [Game Adjust]

### [Settings] > [Game Adjust]

- [Game Mode]: You can select picture modes for game display settings.
  - [Personalized Picture]: Set up a customized picture mode tailored to your preferences. Please install the LG Switch and proceed "Personalized Picture Wizard".
  - [Gamer 1]/[Gamer 2]: [Gamer 1] and [Gamer 2] picture modes allow you to save two sets of customized display settings, including game-related setup options.
  - [FPS]: This mode is optimized for FPS games. It is suitable for very dark FPS games.
  - [RTS]: This mode is optimized for RTS games.
  - [Vivid]: Optimizes the screen for vivid colors.
  - [Reader]: Optimizes the screen for reading documents. (for SDR only)
  - [HDR Effect]: Optimizes the screen for high dynamic range. (for SDR only)
  - [sRGB]: A standard RGB color space for the monitor and printer. (for SDR only)
  - [DCI-P3]: Suitable for watching digital videos. (for SDR only)
  - [Color Weakness]: This mode is for users who cannot distinguish between red and green. It enables users with color weakness to easily distinguish between the two colors. (for SDR only)
  - [Max Brightness]: Optimizes the screen for max brightness.
  - [Calibration 1]/[Calibration 2]: Adjusts to the calibrated screen. Please install LG Calibration Studio to run calibration. (for SDR only)

**! NOTE**

- The [Game Mode] can be set depending on the Input signal.
  - If the [Game Mode] is changed in the DP (DisplayPort) input, the screen may flicker or the resolution of your PC screen may be affected.
  - HDR content may not display correctly depending on Windows OS settings, please check HDR On/Off settings in Windows.
  - When the HDR function is turned on, the characters or picture quality may be poor according to Graphic card performance.
  - While the HDR function is on, screen flickering or cracking may occur when changing the monitor input or power on/off according to Graphic card performance.
  - For information about whether the graphics card and game support HDR, visit their manufacture's website.
- 
- [Dual-Mode]: By increasing the refresh rate, you can experience smoother and faster motion. To change [Dual-Mode] during a game, please exit the game first and then make changes.
    - [Off(Full Wide)]: It can support up to 5120 x 2880 at 165 Hz [HDMI/DP] / 144 Hz [USB-C], and may vary depending on PC performance.
    - [Off(24.5")]: It can support up to 4736 x 2664 at 165 Hz [HDMI/DP] / 144 Hz [USB-C], and may vary depending on PC performance.
    - [On(Full Wide)]: It can support up to 2560 x 1440 at 330 Hz [HDMI/DP] / 288 Hz [USB-C], and may vary depending on PC performance.
    - [On(24.5")]: It can support up to 2368 x 1332 at 330 Hz [HDMI/DP] / 288 Hz [USB-C], and may vary depending on PC performance.
      - » Screen size is changed following each settings.
    - [Dual-Mode] button allows you to switch [Dual-Mode] between [Off(Full Wide)] and the previous selection [Off(24.5")], [On(Full Wide)] or [On(24.5")].
      - » Initially switches between [Off(Full Wide)] and [On(Full Wide)].
  - [Motion Blur Reduction]: This mode minimizes motion blur in fast-moving videos. To take full advantage of this function, select HDMI/DP: 120/144/165 Hz, USB-C: 120/144 Hz before enabling [Motion Blur Reduction].
  - [Adaptive-Sync]/[VRR]: This function shows a clear screen without screen tearing or stuttering in the game environment.
    - However, screen flickering may occur in some game environments.
      - Supported Interface: DisplayPort/USB-C (Adaptive-Sync), HDMI (VRR).
      - Supported Graphic Card: A graphic card that supports NVIDIA's G-SYNC or AMD's FreeSync is necessary.
      - Supported Version: Make sure to update the graphic card to the latest driver.
      - For more information and requirement, refer to NVIDIA website ([www.nvidia.com](http://www.nvidia.com)) and AMD website ([www.amd.com](http://www.amd.com)).
  - [Black Stabilizer]: You can control the black contrast to have better visibility in dark scenes. You can easily distinguish objects on dark game screens.
  - [Response Time]: Sets a response time for displayed pictures based on the speed of the screen. For a normal environment, it is recommended that you use [Fast]. For a fast-moving picture, it is recommended that you use [Faster]. Once [Faster Mode] is selected, [Motion Blur] may occur depending on the content.
  - [Crosshair]: Crosshair provides a mark on the center of the screen for First Person Shooter (FPS) games. Users can select the crosshair that fits their gaming environment among four different crosshairs.
  - [FPS Counter]
    - [On]: The indicator is displayed on the upper left of the screen. It will reflect the actual frame rate that is received at the input. You can also adjust the position of [FPS Counter]. (upper left/upper right/lower right/lower left)
    - [Off]: Does not use the [FPS Counter] feature.
    - [FPS Counter] and [Crosshair] feature can not be used at the same time.
  - [Game Reset]: Returns game settings to the default settings.

## [Picture Adjust]

### [Settings] > [Picture Adjust]

- [Brightness]: Adjusts the brightness of the screen.
- [Contrast]: Adjusts the contrast of the screen.
- [Sharpness]: Adjusts the sharpness of the screen.
- [Gamma]
  - [Mode 1], [Mode 2], [Mode 3]: The higher the gamma value, the darker the image becomes. Likewise, the lower the gamma value, the lighter the image becomes.
  - [Mode 4]: If you do not need to adjust the gamma settings, select [Mode 4].
- [Color Temp]: Set your own color temperature.
  - [Custom]: The user can customize the red, green and blue color.
  - [Warm]: Sets the screen color to a reddish tone.
  - [Medium]: Sets the screen color to between a red and blue tone.
  - [Cool]: Sets the screen color to a bluish tone.
  - [Manual]: The user can fine-tune the color temperature.
- [R/G/B]: You can customize the picture color using red, green, and blue colors.

- [Six Color]: Meets the user requirements for colors by adjusting the hue and saturation of the six colors (red, green, blue, cyan, magenta, and yellow) and then saving the settings.
  - Hue: Adjusts the tone of the screen colors.
  - Saturation: Adjusts the saturation of the screen colors. The lower the value, the less saturated. The higher the value, the more saturated.
- [Black Level]: Sets the offset level (for HDMI only).
  - Offset: As a reference for a video signal, this is the darkest color the monitor can display.
  - [High]: Keeps the current contrast ratio of the screen.
  - [Low]: Lowers the black levels and raises the white levels from the current contrast ratio of the screen.
- [Local Dimming]: Maximizes the contrast ratio by making the bright areas of the screen brighter and the dark areas of the screen darker. Turning this option off may increase energy consumption.
- [Dynamic Tonemap]: Adjusts the tonemap curve of HDR video.
- [Picture Reset]: Returns picture and color to the default settings.

## [Sound]

### [Settings] > [Sound]

- [Sound Out]: Changes the desired audio output method.
- [Bass Boost]: Enhances the bass of internal speakers for richer sound.
- [Volume]: Adjusts the volume level.
  - You can adjust [Mute] / [Unmute] by moving the joystick button to ▼ in the [Volume] menu.

## **[Input]**

### **[Settings] > [Input]**

- [Input List]: Selects the input mode.
- [Aspect Ratio]: Adjusts the aspect ratio of the screen. The display may look the same for [Full Wide], [Original], and [Just Scan] options at the recommended resolution.
  - [Full Wide]: Displays the video in widescreen, regardless of the video signal input.
  - [Original]: Displays video according to the aspect ratio of the video signal input.
  - [Just Scan]: The aspect ratio is not adjusted from the original.
- [Auto Input Switch]: When [Auto Input Switch] is set to [On], display will automatically switch to new input when connected.

## **[General]**

### **[Settings] > [General]**

- [Language]: Sets the menu screen to the desired language.
- [USB-C Option]: Sets the USB-C settings to be optimized for screen resolution or USB data rate.
- [Hexagon Lighting]: Sets the lighting on the back of the monitor.
  - [Static 1], [Static 2], [Static 3], [Static 4]: Sets the lighting to the desired color.
